TRUMP'S BOYS' CLUB EXTENDS TO U.S. ATTORNEYS

Donald Trump fired dozens of federal prosecutors in March and has slowly been announcing their replacements. As of Nov. 1, Trump had nominated or announced the nomination of 53 people to be U.S. attorneys. An American Bridge analysis found that 50 of 53 – more than 94 percent – of the nominees are men.

In September, <u>The Guardian</u> published American Bridge data showing that 80 percent of Trump's nominees across the government were men.
